The County Treasurer's Office acts as the bank for the County departments, school districts, fire districts, special purpose districts and other units of local government, by receipting, disbursing, investing, and accounting for the funds of each of these entities. The Treasurer's Office is also charged with the collection of various taxes that benefit a wide range of governmental functions.



2015 Accomplishments

- Provided an additional fraud prevention service to Districts who issue warrants by initiating payee positive pay with Key Bank, which reduces the risk of altered checks and counterfeit check fraud.
- Received certification by the Washington Public Treasurer's Association for the Yakima County Investment Policy.
- Transitioned to a new third-party vendor for online debit/credit cards and e-check payments in order to reduce the fees charged to the taxpayer.
- Partnered with CivicPlus, a website developer focused on local government, to update and standardize Yakima County's website.
- Conducted the first online foreclosure auction using Bid4Assets.com. This allowed our office to expedite the process of collecting unpaid taxes for the taxing districts and allowed interested parties to bid on properties from any location where internet access was available.
- Successfully sold 12 Tax Title properties through the private negotiation process which positively impacts the taxing districts by placing these properties back on the tax rolls for future year's collections.

Real Estate Excise Tax Affidavits Processed

In 2011, the Treasurer's Office implemented eConvey, the electronic processing and reporting system for the receipt of real estate tax affidavits submitted to our office. This created greater efficiencies in processing the documents, as well as allowing for the electronic submission of all excise tax affidavits to the WA State Department of Revenue rather than manually preparing and mailing those documents on a monthly basis.



County Treasurer's Investment Pool Portfolio


The Yakima County Treasurer's Office actively manages an investment pool portfolio of approximately \$350 million. The Treasurer's Investment Pool (TIP) was established April 1, 2005 to create a locally managed diversified investment option that would achieve a potentially higher yield than other investment options. The investments of Yakima County, as well as most districts in the County, are pooled together in TIP. There are over 280 different funds currently participating in the TIP.

County Pool (TIP) - Gross Interest Rate Comparison Historical Performance vs. Benchmarks



Goals for 2016

Expand the partial payment program currently in place for delinquent taxes.

Enhance the property tax information application on our website with new robust technology which will improve future development and create efficiencies.

In partnership with other Yakima County offices, we will evaluate our current financial system to determine if it is advisable to purchase new software or expand our existing software. The primary objective will be obtaining newer technologies that allow for greater efficiencies in our offices.
